Our mission in the SCCF is to positively impact the quality of life and development of 'youth in need' in the Greater Tucson Area. This year, we accomplished our best fundraising efforts to date resulting in annual grants totaling \$250,000 to 20 deserving charities and, for the eighth consecutive year, a \$10,000 contribution to the U of A golf teams. That brings our combined lifetime total donation to **nearly \$2 Million dollars**. Our deepest thanks go to our donors and sponsors who supported our events by generously giving their time, their gifts, and their dollars.

This year's Fall Fundraising Event had a theme of "Through the Decades - '50s, '60s and '70s." The decorations, drinks, appetizers, desserts and music all were derived from those years, and we dressed the part. Best of all was our record setting funds total of \$157,227.

**Cats in the Canyon** had its best ever participation as we sold out the tee times for the Spring Golf Event several weeks in advance. It also accomplished a new fundraising record with stronger than ever sponsorships and auction results. As always, we are grateful for our partnership with the University of Arizona Women's and Men's Golf Teams, Mickelson Golf, and the Stone Canyon Club.

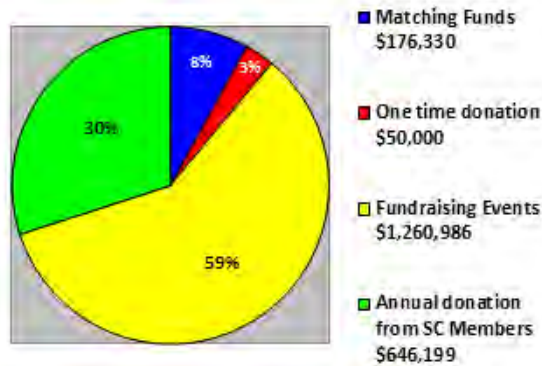

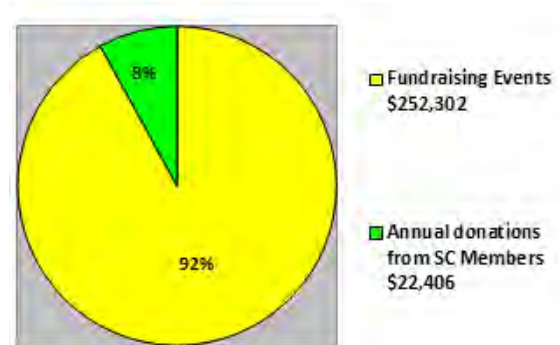
## SOURCES OF SCCF FUNDS
