HISTORY

Stone Canyon Community Foundation (SCCF) was founded by a group of six generous families who focused on the contrast between the wonderful place we live and the strained economics of our less fortunate neighbors. They wanted to make a difference and eventually chose YOUTH-IN-NEED because they knew that enhancing opportunities for young people to succeed provides the best chance for sustained improvement.

WHY A LEGACY FUND FOR SCCF?

SCCF's long term goal is to grow the legacy fund so that most of its income (to fund grants) would flow from this source rather than annual fund-raising or giving campaigns. This will have the following benefits:

- Event-based funding is by nature volatile, and relying less on this would make annual grant-making more predictable and stable.
- Volunteer led events are important parts of SCCF's income plans, but they require large time commitments and reducing their size and scope would make it easier to attract and retain committed people.
- Economic conditions would be less of a factor in annual giving because the stability of a legacy fund would permit SCCF to ride out recessions or other economic hurdles and thus be a more secure source of funding to our agencies.

WHY A LEGACY FUND FOR DONORS?

A legacy fund is a great choice for donors for a variety of reasons:

- It offers multiple options to donate without affecting your current income.
- Depending upon the route chosen, it is adjustable at any time during your life and under certain circumstances, tax benefits will accrue.
- A legacy fund ensures the continuity of giving by matching the long-term problems of YOUTH-IN-NEED with a long-term source of funding.
