When the 2019-2020 season started, no one knew the challenges the world...and the Stone Canyon Community Foundation...would face.

In July 2019, an Appeal Letter was sent to all Stone Canyon members asking for help to jump-start the Fall fundraising campaign. The response of the Stone Canyon community was overwhelming and over \$183,000 was received! **Kicking It Up for the Kids** quickly followed in November, where over 145 SC members attended a fun evening that included silent and live auctions, a raffle for a 2019 Jeep Grand Cherokee, a delicious dinner and lots of dancing. When it was over, more than \$49,500 additional funds were raised to support the SCCF vision – Empowering youth to achieve their dreams!

It was such a great start! Then in April, planning was well underway for **Cats** in **the Canyon** with SCCF's partners, the University of Arizona Men's and Women's golf teams. Invitations were sent and the event sold out in record time. Then the unexpected happened – COVID-19 – and CATS was canceled.

Quickly, the local non-profit agencies scrambled to institute policies and procedures to keep the youths they served safe, resulting in new expenses for Personal Protective Equipment, additional staffing and a surge in the demand for their services. Their operating expenses skyrocketed at the same time their funding was being reduced. To make matters worse, the SCCF's ability to fund the upcoming grant cycle, which would help provide the needed assistance, was threatened.

Everything changed.... everything, that is, except Stone Canyon Members' commitment to help Tucson's youth-in-need. The SC members and corporate sponsors who had previously signed up for CATS were asked to convert their admission fees and sponsorships into donations. Not only did that happen, but even additional donations were made. The SCCF received over \$57,600, with virtually no expenses! When combined with donations from the Fall Campaign, the SCCF netted a grand total of over \$290,100 for the June 30, 2020 fiscal year end!

The generosity and support of the Stone Canyon members saved the day!

In addition to celebrating the holidays, the event benefited Reunion House, a shelter for young adults between the ages of 18-24 which is part of the Our Family Services non-profit agency. The 60 ladies who attended contributed bedding, towels, hygiene products and household items filling two SUVs for direct delivery to Reunion House.

The award-winning sounds of the **Tucson Girls Chorus** echoed through the SC Clubhouse on February 26th. # NEW THIS YEAR! SCCF LEGACY FUND

When planning began for the SCCF Legacy Fund, COVID-19 did not exist. However, the leadership of the Foundation recognized the limitations and risks of funding SCCF grants solely by holding volunteer-led fund-raising events and seeking individual member donations. The arrival of COVID-19 proved that their concerns were well-founded when this year's planned events, the main sources of SCCF's funding, were canceled.

The SCCF Legacy Fund's purpose is to ensure an alternative source of funding to make annual grants more predictable and stable. Creating a steady source of income, regardless of economic conditions, will protect the ability of the SCCF to continue to issue grants supporting critical programs of local non-profit agencies who assist Tucson's youth-in-need. The SCCF Legacy Fund was developed in partnership with the Community Foundation for Southern Arizona (CFSA). CFSA has the infrastructure to accept current or estate gifts on behalf of the SCCF.

SCCF's intention is to grow the Fund over time. The original goal set for the Legacy Fund was to attain \$5 million in pledges over a 10-year period. Impressively, the SCCF Legacy Fund has already received pledges of more than \$3 million in the first six months!

### 2020-2021 SCCF GRANTS COMMITTEE

The Grants Committee is central to carrying out the SCCF Mission by screening grant applications submitted by local non-profit organizations. The agencies are required to demonstrate how they help achieve educational success and positively impact the quality of life for youth-in-need in Oro Valley and Tucson.

The committee reviews the grant applications, visits non-profit organizations, evaluates past performance, and decides which organizations' requests are most in line with the SCCF Mission.

It's a big job! Last year, 45 grant applications were submitted requesting funds from the SCCF – more than double than were able to be funded. The SCCF grant process is impressive and can be reviewed on the SCCF website: stoneccf.org
